

High-Efficiency Toilet (HET) Rebate Home Owners Association Application

ELIGIBILITY:

- A non-member receiving service through a Home Owners Association is eligible with authorization from the HOA for receipt of credit.
- Residential property only.
- Applications must be received within 60 days of the purchase date.
- Prior to rebate approval, an on-site inspection may be required.



TERMS OF REBATE:

- \$100.00 HET rebate; limit two HET rebates per household.
- The new toilet must be 1.6 gallons per flush or less (1.28 gallons encouraged) **AND** replace a non-efficient toilet.
- Applicants must include a copy of proof-of-purchase from a store or plumber that specifies the purchase date and price, manufacturer and model number.
- The rebate per item will not exceed the receipt amount.
- Rebates will be credited to the member's account.
- The applicant is responsible for properly disposing of the old toilet. They may be disposed of through garbage collection special pickup.
